ORDER

The Administrative sanction for an amount of Rs. 48106/- , under Special Development Fund of Sri. Saji Cherian, Hon. MLA, Chengannur has been received from the District Collector, Alappuzha for providing electric connection to the Thottumkara Padasekaram by converting 90m of the existing LT single phase line to three phase line and 30m WP portion, under Electrical Section, Mulakkuzha.

The Executive Engineer, Electrical Division, Chengannur , as per letter read as 1st above , has informed that the amount for the execution of works was not remitted. A letter dated 02.12.2020 was sent to the District Collector, Alappuzha, requesting disbursement of the estimate amount in advance for the execution of the works.

Further, Sri. Saji Cherian, MLA, vide letter dated 02.12.2020, requested the Executive Engineer to take necessary steps urgently to give supply to the Thottumkara Padasekaram to start paddy cultivation at the right time.

As per the Administrative Sanction Order of the District Collector, Alappuzha, the expenditure for the above works will be met from the funds allotted to the Chengannur LAC for the year 2020-21. Also, the work is to be completed before 31.03.2021. The request of the Hon'ble MLA is genuine and the same is recommended.

Considering the urgency, the service connection was effected to the Thottumkara Padasekaram by the Executive Engineer, Electrical Division, Chengannur. Hence, ratification is requested on the above action.

Having considered the matter in detail, the Full Time Directors in the meeting held on 07.01.2021, resolved to ratify the action taken by the Executive Engineer, Electrical Division, Chengannur in having effected service connection to Thottumkara Padasekaram, before payment of the AS amount considering the urgency to start paddy cultivation at the right time.

Further resolved to direct the Executive Engineer, Electrical Division, Chengannur to take up the matter with the District Collector, Alappuzha, for remitting the estimate amount required for the works.

Orders are issued accordingly.
