Construction of building for accommodating Electrical Section, Puthur under Electrical Circle, Thrissur – Approval of plan and Administrative Sanction – Accorded – Orders issued

ORDER

As per the letter read as 1st above, the Chief Engineer (Distribution Central), Ernakulam has reported that the Electrical Section, Puthur is presently accommodated in a rented building near Vettukadu at a monthly rent of ₹13,000/-. The Section has a monthly demand of more than Rupees one crore of monthly demand with 2 HT consumers and provides service to all types of consumers including BPL and agricultural. The 110 kV Substation, Ollur and 33 kV Substation, Puthur are feeding the Section. The office is now accommodated in the first floor of the building for which sufficient storage space is not available. Hence a permanent office building is proposed for accommodating the Electrical Section, Puthur in the land of about 15cents available at 33 kV Substation, Puthur. A double storeyed building having a total plinth area of 237.87 m² [Ground floor–125.17 m² and first floor–112.70 m²] is proposed for Electrical Section, Puthur. The approximate cost of construction for the proposed building comes to ₹85,00,000/-.

In the above circumstances, the Chief Engineer (Distribution Central), Ernakulam requested Administrative Sanction for an amount of ₹85 lakh for the construction of building for accommodating Electrical Section, Puthur in the land available at 33 kV Substation, Puthur.

The matter was placed before the Full Time Directors as per the note read as 2nd above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 07/01/2021, resolved to accord sanction for constructing a double storeyed building for accommodating Electrical Section, Puthur in the land available at 33 kV Substation, Puthur. Further resolved to approve the plan for the construction of the building having a total plinth area of 237.87 m² [Ground floor – 125.17 m² and first floor – 112.70 m²] by limiting the total cost of construction to ₹85 lakh.

Orders are issued accordingly.
