#### ORDER

Two part e-tenders were invited vide bid No.KSEB/SCM/eP-32/20120-21 dated 29.06.2020 for the procurement of steel raw materials for Distribution and Transmission works, with Probable Amount of Contract of Rs.54.00 Crore, for meeting the balance requirement for plan works of 2019-20 and for the requirement in 2020-21. The total quantity tendered was 10869 MT of steel raw materials for supply at the three manufacturing Units of KSEBL at Pallom, Angamaly and Kolathara.

Nine firms participated in the tender. The pre-qualification bids were opened on 16.07.2020. M/s Jindal Steel and Power Ltd, Kochi has offered their bid by taking commercial deviation of 100 % advance payment and unloading exemption. Pre-Qualification committee meeting held on 23.09.2020 (Agenda Item No.02/2020-21(Dn)) decided to pre qualify four bidders M/s Balajee Structurals India Limited, Raipur, M/s.Sanvijay Rolling and Engineering Limited, Nagpur, M/s Jindal Steel & Power Limited, Kochi and M/s Steel Authority of India Limited, Kochi.

The price bids were opened on 01.10.2020. M/s Jindal Steel and Power Limited, Kochi has quoted rates excluding unloading charges. Hence KSEBL's unloading charges were added with their quoted rate for arriving L1 rate. The L1 bidders are M/s Jindal Steel and Power Ltd, M/s Balajee Structurals India Limited, Raipur and M/s Sanvijay Rolling and Engineering Limited, Nagpur. All the details pertaining to the bid along with the recommendation of the Chief Engineer (SCM) and the remarks of the Financial Adviser were placed before the Purchase Committee meeting held on 20.11.2020 (Agenda Item No.13/2020-21) for decision and it was decided to place the matter before the Director Board, after intimating M/s Jindal Steel and Power Limited that there is no provision in the tender document for advance payment and getting clarification from M/s Balajee Structurals India Limited, Raipur for the rates quoted at Kolathara.

M/s Jindal Steel and Power Limited, Kochi intimated that they are not ready to withdraw the above deviation and requested to admit the advance payment since they have quoted the bid with the above commercial deviation and the Pre Qualification Committee qualified them. M/s Balajee Structurals India Limited, Raipur clarified that they have quoted item no.34 for delivery at MF2, Kolathara.

The proposals decided in the Purchase Committee were placed before the Board of Directors as per note read 2 above. Having considered the matter in detail, the Board of Directors in its 56<sup>th</sup> meeting held on 01.01.2021,

1. Resolved to authorize the Chief Engineer (SCM) to place Purchase Order with M/s Jindal Steel and Power Limited, Kochi as detailed below, for the supply of steel items against Bid No.KSEB/SCM/eP-32/2020-21 dated 29.06.2020 at their quoted rates, involving a total financial commitment of ₹ 38,62,32,300 (Rupees Thirty Eight Crore Sixty two lakh, Thirty two thousand and Three hundred only), without allowing the request of the firm to grant advance payment against Bank Guarantee for the full purchase value for a period of supply for 2 months. If the supplier back out from the offer, due to non payment of advance, which is not envisaged in tender, the supplier shall be blacklisted from participating in future tenders.
