## ORDER

As part of the Chief Minister's 12 point priority projects of Government of Kerala, Nilaavu scheme envisages the replacement of all conventional street lights with LED Street Lights in all local bodies across Kerala, in a phased manner for reducing electricity consumption and environmental impact.

Based on the recommendations of the Director (Planning & Safety) regarding the responsibilities to be assigned to the Chief Engineers of Distribution wing for rolling out the NILAAVU project, The Chairman & Managing Director had accorded sanction and issued Orders read as 1<sup>st</sup> above to:

1. Designate the Chief Engineer (DS) as the State Nodal Officer for rolling out the Nilaavu Project in all LSGs across the State, with responsibilities to issue Letter of Intent (LoI)/Purchase Order to EESL, execution of purchase agreement, issuing payment release instruction to KIIFB, coordination of the works related to the project in liaison with Government departments, KIIFB, EESL etc.
2. Direct the Chief Engineers (Distribution - Central / North / North – Malabar) to furnish LSG wise consolidated reports to Chief Engineer (Distribution South) regarding requirement, supply, installation, failure reports, warranty replacement etc on monthly basis.
3. Authorise the Chief Engineer (IT&CR) to develop a suitable IT platform for monitoring and reporting

The Chairman & Managing Director also directed to place the matter before the Full Time Directors for ratification.

Accordingly the matter was placed before the Full Time Directors for ratification as per note read as 2<sup>nd</sup> above. The Full Time Directors in their meeting held on 07.01.2021, resolved to ratify the action of issuing office order read as 2<sup>nd</sup> above designating and authorising the officers for carrying out various responsibilities for the implementation of NILAAVU project.

Orders are issued accordingly.
