ABSTRACT

Supply, Laying, Termination, Testing & Commissioning of 10.5km of 110kV, 3 Nos. Single Core 630Sq.mm Aluminium Conductor XLPE UG Cable and Single Run Single Mode 24 OFC from 110kV Substation, Kollam to Kottiyam Substation under Transmission Circle, Kottarakkara – Approval for Tender finalization - Sanction accorded – Orders issued – reg.

ORDER

Administrative Sanction was accorded for an amount of Rs.33.5 Crore as per BO read as 1st above, for interlinking 110kV Substation, Kollam with 110kV Substation, Kottiyam under Transmission Circle, Kottarakkara. The work involves:

- a. Construction of foundations for yard equipments, columns, cable trench etc., in connection with the laying of 110kV Cable for interlinking the Kollam & Kottiyam 110kV Substations.
- b. Supply, Laying, Termination, Testing & Commissioning of 10.5km of 110kV, 3 Nos. Single Core 630Sq.mm Aluminium Conductor XLPE UG Cable and Single Run Single Mode 24 OFC from 110kV Substation, Kollam to Kottiyam 110kV Substation.

The Chief Engineer (Trans. South) invited Two Part Tender (e-tender read as 2nd above) for the Part b portion of the work with PAC of Rs. 23,10,98,484.14 (including GST). Seven bidders participated in the tender and all of them were prequalified in the PQ meeting held on 03.12.2020. The tender documents were opened on 10.12.2020.

M/s.Polycab India Limited, Mumbai has quoted the lowest rate of 9.03% below PAC. On negotiation, the lowest bidder offered a discount of Rs.2,10,237.71 on the quoted amount of Rs.21,02,37,707.23. Hence, the amount after deducting the discount offered is Rs.21,00,27,469.52 which is 9.117% below PAC.

The Chief Engineer (Transmission South) suggested that the Work Order can be placed with the lowest bidder for the said work for an amount of Rs.21,00,27,469.52.

As per the Delegation of Powers, the Chief Engineer can invite tenders for works without limit and accept the same if the bid amount is equal to or less than PAC. But for works above, Rs.10 Cr., approval has to be obtained from the Full Time Directors before finalising the tender. As the estimate amount of the subject work exceeds Rs.10 Crore, the matter was placed before the Full Time Directors for obtaining approval for tender finalisation, as per Note read as 4th above.

Having considered the matter in detail, the Full Time Directors, in the meeting held on 07.01.2021,

Resolved to accord sanction for finalising the tender with the lowest bidder, M/s. Polycab India Limited, Mumbai for supplying, laying, termination, testing & Commissioning of 10.5km of 110kV, 3 Nos. Single Core 630Sq.mm Aluminium Conductor XLPE UG Cable and Single Run, Single Mode 24 OFC from 110kV Substation, Kollam to 110kV Substation, Kottiyam under Transmission Circle, Kottarakkara, at their negotiated rate of Rs.21,00,27,470/- (Rupees Twenty One Crore Twenty Seven Thousand Four Hundred and Seventy Only) with GST which is 9.117% below the PAC.

Orders are issued accordingly.
