## **ORDER**

E-Tenders for the work "Hot dip galvanization of 11745 MT electric line materials such as Cross arms, Clamps, Stay rods etc. and Lattice tower parts, fabricated at the Mechanical Facilities of KSEB Ltd. for the year 2020-21" having estimated PAC Rs. 22,10,09,950/- was invited by the Chief Engineer (Civil Construction) South as per e-Tender No. CECCS/03/2020-21 dated 21.07.2020 by giving wide publicity as per norms. The last date of on line submission of tender and date of Prequalification bid opening were on 14.08.2020 and 21.08.2020 respectively. These dates were extended up to 21.08.2020 and 26.08.2020 respectively. Five bidders submitted their offer.

The pre-qualification bids of the five bidders were opened and the pre-qualification committee held on 03.11.2020 decided to pre-qualify M/s. TJSV Steel Fabrication and Galvanising (India) Ltd., Tirupur and M/s. Sanvijay Infrastructures Private Limited, Nagpur for the subject work. Accordingly, the price bids of the above two bidders were opened on 10.11.2020 at 11.00 AM and M/s. TJSV Steel Fabrication and Galvanising (India) Ltd. is the lowest bidder with a quoted amount of Rs. 24,70,02,430/- excluding GST. The quoted amount is 11.76 % above estimated PAC.

The Chief Engineer (Civil construction) South as per their letter dated 11.11.2020 has requested M/s. TJSV to offer their rock bottom rate for the work and M/s TJSV has revised the offer price of line material as follows.

CMF Pallom	Rs 21,150/MT	
MF1 Angamaly	Rs 20,800/MT	
MF2 Kolathara	Rs 20,900/MT	

The reduced quoted amount comes to Rs. 24,66,62,500/- excluding GST which is 11.61% above the estimated PAC.

The Financial Adviser as per note read as 2<sup>nd</sup> above has remarked that, as the rate is 11.61% above estimate, negotiation at next higher level is advisable. Accordingly, the firm was requested from the Board level by the Director (Gen- Civil) to offer their rock bottom rate as per letter read as 4<sup>th</sup> above and M/s TJSV as per their letter dated 18.12.2020 expressed their difficulty in reducing further the rate.

The Chief Engineer (Civil Construction) South as per note read as 3<sup>rd</sup> above has reported that galvanization of fabricated products is to be continued without break to achieve the targets and for this the new contract is to be executed without delay and has also recommended to award the work to the lowest bidder M/s TJSV Steel Fabrication and Galvanizing (India) Ltd.

The matter was circulated as per the note read as 6<sup>th</sup> above among the Full Time Directors on 22.12.2020 and decision was taken for placing the matter before the Board of Directors of KSEBL.

Accordingly the matter was placed before the Board of Directors as per note read as 7<sup>th</sup> above and the Board of Directors in its 56<sup>th</sup> meeting held on 01.01.2021 (Agenda No 26-12/2020) discussed the matter in detail and RESOLVED to accord sanction to award the work 'Hot dip galvanization of 11745 MT electric line materials such as Cross arms, Clamps, Stay rods etc: and Lattice tower parts, fabricated at the Mechanical Facilities of KSEB Ltd. for the year 2020-21' to the lowest bidder M/s. TJSV Steel Fabrication and Galvanizing (India) Ltd. at their reduced quoted amount of Rs. 24,66,62,500/- (Rupees Twenty-Four Crore Sixty-Six Lakhs Sixty-Two Thousand and Five Hundred only) excluding GST (overall percentage excess 11.61%).

Orders are issued accordingly. The Chief Engineer (Civil Construction) South shall take further necessary action in this regard.
