ORDER

The Secretary, Power Department has requested as per letter read as 1st above for furnishing comments regarding the request of the DGP & State Police Chief, Kerala for allocation of rack space in KSEB Data Centre for co-locating the CCTNS infrastructure of Police Department. The DIG(APB) & Nodal Officer-CCTNS has also requested as per letter read as 2nd above to allocate 20U rack space for the same purpose.

The Chief Engineer (IT, CR & CAPs) as per Note read above has reported that the rack space in KSEB Data Centre is almost exhausted and the space for hosting a few more racks is remaining. Implementation of various centrally aided projects like large scale Smart Meter deployment, ERP etc. and IT automation of Solar Plants, EV Charging Stations, various Data Analytics projects etc. are to be commenced shortly. Since there are no other options for further scale up of rack space in the Data Centre other than decommissioning of the existing hardware, it may not be advisable to lease rack space to outside agencies on a permanent basis.

Considering the above facts, the Chief Engineer (IT, CR & CAPs) has suggested to allocate rack space in KSEB Data Centre for Police Department subject to the following:

- 20U rack space will be provided with an allowable IT load of 5KVA on temporary basis for a maximum period of one year
- Hosting charges of Rs. 7 Lakhs for the one-year hosting period shall be remitted as advance payment
- A Commercial Agreement for Data Centre co-location services shall be executed by Police Department incorporating the terms and conditions for leasing the rack space.

The matter was placed before the Full Time Directors as per Note read as 3rd above. Having considered the matter in detail, the FTD in its meeting held on 16.12.2020 resolved to accord sanction to allocate rack space in KSEB Data Centre for Police Department subject to the following:

1. 20U rack space will be provided with an allowable IT load of 5KVA on temporary basis for a maximum period of one year
2. Hosting charges of Rs. 7 Lakhs for the one-year hosting period shall be remitted as advance payment
3. A Commercial Agreement for Data Centre co-location services shall be executed by Police Department with the Chief Engineer (IT, CR & CAPs) incorporating the terms and conditions for leasing the rack space.

Further resolved to approve the draft letter to Power Department in this regard.

Orders are issued accordingly.
