## **ORDER**

The Chief Engineer (IT,CR & CAPs) as per note read as 4<sup>th</sup> above has reported that KSEBL as per order read as 1<sup>st</sup> above had formed 10 Field IT Sub Units viz-Thiruvananthapuram, Kollam, Kottayam, Ernakulam, Idukki, Thrissur, Palakkad, Malappuram, Kozhikode and Kannur with staff strength of one System Administrator and two System Supervisor. KSEBL has also allotted vehicles to all System Administrators as per BO read 2 and 3 above except System Administrator-Kollam, as the System Administrator was on working arrangement at IT (Computerization Unit), Thiruvananthapuram. Now the System Administrator is working with headquarters at Electrical Circle Kollam as per Board Order read (1) and is in charge of all the computerization activities of entire district of Kollam.

In view of the above, the Chief Engineer (IT,CR & CAPs) recommended to allocate one hired vehicle (car) for the use of System Administrator, IT Sub Unit, Kollam with a kilometer limit of 1500 km/month simlar to all other System Administrators in the state. Also recommended to authorise Deputy Chief Engineer, Electrical Circle, Kollam to arrange the hired vehicle for System Administrator, IT Sub Unit, Kollam.

Having considered the matter in detail, the Full Time Directors in its meeting held on 16.12.2020, resolved to accord sanction to allocate one hired vehicle (car) for the use of System Administrator, IT Sub Unit, Kollam with a kilometer limit of 1500 km/month.

Further resolved to authorize the Deputy Chief Engineer, Electrical Circle, Kollam to arrange the hired vehicle for System Administrator, IT Sub Unit, Kollam.

Orders are issued accordingly.
