50 MW Solar Plant at Kommangala (Paivalike), Kasaragod – Constituting Technical and Commissioning Committees – Approved-Orders issued.

ORDER

The Ministry of New and Renewable Energy (MNRE), Government of India (GoI) had given approval for setting up of 105 MW Solar Park at Kasaragod. Out of the 105 MW sanctioned, the 50 MW Solar plant at Ambalathara in Kasaragod was commissioned in 2017. Another 50 MW Solar plant is being set up at Kommangala (Paivalike), Kasaragod and the works are nearing completion. The Chief Executive Officer (CEO), Renewable Power Corporation of Kerala Limited (RPCKL) as per letter read as 1st above reported that a Technical Committee and a Project Commissioning Committee are to be constituted as per MNRE guidelines, incorporating various stakeholders, for commissioning the project at Paivalike. The CEO forwarded the list of members to be included in the Committees, based on the nomination received from the stakeholders viz. SPPD, SECI, SPD, STU, KSEBL and EPC Contractor of the project and sought approval for the same.

The matter was placed before the Full Time Directors as per note read as 2^{nd} above .

Having considered the above, the Full Time Directors, in the meeting held on 24.12.2020, resolved to accord sanction to constitute the Technical Committee and the Commissioning Committee as below, as part of Commissioning of the 50 MW Solar plant at Kommangala (Paivalike).
