## <u>ORDER</u>

KSEBL had accorded sanction as per B.O read 1<sup>st</sup> above, for hiring a vehicle with driver on contract basis for the use of TC Section Vandanmedu for the construction of 110kV Substation Murikkassery with a monthly kilometer ceiling of 1500km for a period of one year/till the completion of the works, whichever is earlier.

The Chief Engineer, Transmission South as per letter read as  $2^{nd}$  above reported that, E-tender was invited by the Deputy Chief Engineer Transmission Circle Thodupuzha for the supply of diesel jeep with driver for the use of T.C. Section Vandanmedu for a period of one year. Competitive tenders are invited four times after giving wide publicity. First tender was canceled as the tenderer had quoted high rate of ₹ 23.98/km. No tenders received for the second and third time. Regarding the 4<sup>th</sup> tender (last tender), two tenders were received and the lowest tenderer Sri. Anil P Lukose Punnolil (H) Parathode P.O., Idukki has quote ₹20/km for 1500km and ₹20/km for above 1500km. After negotiation the tenderer reduce his quote to ₹19.80/km for 1500 km and ₹19.80/km for above 1500km. It is 5.88% above, the approved rate.

The Chief Engineer, Transmission South has reported that the chances of getting a better offer on retender seems to be remote considering the present hike in price of fuel and maintenance cost. Also the vehicle is highly essential for the use T.C. section Vandanmedu for monitoring the ongoing major works of 110kV Substation Murikkassery.

The Chief Engineer Transmission South has requested to sanction to award the subject work to the lowest tenderer Sri. Anil P Lukose,Punnolil (H), Parathode P.O., Idukki at his negotiated quoted rate of ₹19.80/Km (amounting to ₹ 29,700/-) for initial 1500km and ₹19.80/km for above 1500km for a period of one year.

The matter is placed before Full Time Directors as per note read as 3<sup>rd</sup> above Having considered the matter in detail, the Full Time Directors in the meeting held on 16.12.2020

Resolved to accord sanction to award the work of hiring of diesel jeep with driver for the use of T.C. Section Vadanmedu ( for the use of construction works of 110kV Substation, Murikkassery) for a period of one year / till the completion of the works, whichever is earlier, to the lowest tenderer Sri. Anil P Lukose, Punnolil (H), Prathode P.O., Idukki at his quoted rate of  $\overline{\mathbf{x}}$ . 19.80/km (amounting to  $\overline{\mathbf{x}}$ .29,700/-) for initial 1500km which is 5.88% above the approved rate and  $\overline{\mathbf{x}}$ .19.80/km for above 1500km.
