## ABSTRACT

## ORDER

The Deputy Chief Engineer, Electrical Circle, Kollam has invited Tender cum auction for the disposal of 4000 litres of old and unusable transformer oil available at TFRU, Kollam, with an assessed scrap value of Rs.1,26,300/-, after completing all formalities including newspaper notification. As no tender forms were sold during the specified time and as no bidders have participated in the auction, the time schedule for the tender cum auction was extended to 31.10.2020 & 02.11.2020 respectively. Again, no tender forms were sold, and only one participant viz. M/s. CEE JEE Lubricants, VI/592, /Industrial Development Area, Edayar, Binanipuram P.O, Aluva 683 502 has participated in the auction and quoted an amount of Rs.1,26,400/- (Rs.31.60/- per litre). ie 0.079% above the assessed vale. The firm was not willing for further negotiation and the auction was temporarily confirmed at the quoted rate of Rs.1,26,400/-.

The Deputy Chief Engineer recommended the earlier disposal of the transformer oil as the storage of old and unusable transformer oil is causing inconvenience and also the delay in the disposal of oil may cause deterioration of oil and barrels. Based on the report of the Deputy Chief Engineer, Electrical Circle, Kollam that the chances of getting better

offer on re-tender is remote, considering the poor response of qualified persons in the tender cum auction and subsequent recommendation of the Chief Engineer, Distribution (South), matter was placed before the Full Time Directors as per note read 5 above, to confirm the sale order in favour of the single bidder M/s. CEE JEE Lubricants, Aluva, at the quoted rate of Rs.1,26,400/-.

Having examined the matter in detail, the Full Time Directors in the meeting held on 16.12.2020, resolved to accord sanction to the Chief Engineer, Distribution (South) to confirm the sale order for the old and unusable transformer oil tendered by the Deputy Chief Engineer, Electrical Circle, Kollam to the single bidder, M/s. CEE JEE Lubricants, Aluva, at the quoted rate of Rs.1,26,400/- which is 0.079% above the assessed value of Rs.1,26,300/-.

Orders are issued accordingly.
