ORDER

The Chief Engineer (Generation&PED) as per letter read as 1st above reported that the Erection Subdivision, Kakkayam is entrusted with the E&M erection activities of all the ongoing/new projects under the Chief Engineer, Civil Construction North (CECCN), Kozhikode. The major ongoing projects are Chathankottunada Stage II, Pazhassi Sagar and Peruvannamuzhy SHEPs. The erection works of Chathankottunada SHEP is progressing and scheduled to be completed by March 2021. The E&M works of Pazhassi Sagar and Peruvannamuzhy SHEPs are in the awarding stage and the works of Olikkal, Poovaramthodu and Maripuzha SHEPs are in tendering stage. The balance works of the already commissioned projects mainly Barapole SHEP, Kakkayam SHEP, KTR, Adyanpara etc are also carried out by this Subdivision. Among the projects, Barapole and Pazhassi Sagar SHEPs are around 200 kilometers away from the Erection Subdivision, Kakkayam and extensive travel is required for supervising the works of the above projects.

It is reported that, the only available vehicle in the sub division is a 1994 model Mahindra 540 jeep (KL07 G9829, 4 wheel drive) which is 26 years old and has to be survey reported as per the Board Order read as 2nd above. At present no Department Vehicles are available with the ARU, CECCN, Kozhikode and the only option is to hire a vehicle. The Chief Engineer (Generation & PED) has further reported that two Department vehicles; Mahindra Thar model jeeps (KL01CC6361 and KL01CC6480) are available with the Investigation Division, Kozhikode under the Investigation Circle, Thrissur and requested to reallocate one of the above jeeps to the Erection Sub Division, Kakkayam so as to carry out the works/erection activities efficiently. The remarks of the Director (Generation-Civil) were obtained in this regard.

Having considered the matter in detail as per Note read as 5th above, the Full Time Directors in the meeting held on 16-12-2020, resolved to accord sanction to allot one of the jeeps attached to Investigation Division, Kozhikode under Investigation Circle, Thrissur to Erection Sub Division, Kakkayam.

The Chief Engineer (Civil -Investigation & Construction Central) shall take necessary action in this regard.
