ORDER

KSEB Ltd as per B.O read as 1st above had accorded sanction to award the Comprehensive Annual Maintenance Contract of the lifts LG-1459 & LG-1116 (Lift No 5 & 6) installed at Vydyuthi Bhavanam, Thiruvananthapuram to M/s. Johnson Lifts Pvt Ltd for the period from 13.01.2020 to 12.01.2021 and the Executive Engineer, Civil Division, Thiruvananthapuram had accordingly entered into the contract agreement with the firm. Since the period of AMC of the lifts will expire on 12.01.2021, M/s Johnson Lifts Pvt Ltd as per their letter 20.11.2020 has intimated their willingness to continue the AMC and furnished their rates for carrying out the work under Platinum package. The offered rate includes periodical inspection and carrying out routine/ preventive monthly maintenance, break down maintenance, repair/replacement of all defective parts of the lift excluding consumable parts viz. fan and light fittings, alarm device and batteries etc. As the offered rates are 12% higher than the existing rates, negotiation for reducing the rates were conducted with the firm by the Executive Engineer, Civil Division, Vydyuthi Bhavanam, Thiruvananthapuram and M/s Johnson Lifts Pvt Ltd has offered their lowest rates as per their letter 28.11.2020 for carrying out the work for the next three years.

The Chief Engineer (Civil Construction – South) as per note read as 2nd above has pointed out that, in order to get prompt service and original spares, it is better to entrust the AMC of the lifts to the original manufacturers, M/s. Johnson Lifts Pvt. Ltd based on their negotiated rate waiving the tender procedures. The rates after negotiation are 6 % more than the existing rates, which is very reasonable. The Chief Engineer has requested sanction to award the Annual Maintenance Contract for the lifts LG 1459 & LG 1116 (lifts No. 5 & 6) installed at Vydyuthi Bhavanam, Thiruvananthapuram to M/s. Johnson Lifts Pvt. Ltd at their negotiated rates under platinum package for a period of 3 years on expiry of the existing contract.

The matter was placed before the Full Time Directors as per note read as 3rd above. Having considered the matter in detail the Full Time Directors of KSEBL, in the meeting held on 16.12.2020, Resolved to accord sanction to award the Comprehensive Annual Maintenance Contract for the lift No. 5 & 6 (LG 1459 & LG 1116) installed at Vydyuthi Bhavanam, Thiruvananthapuram to M/s. Johnson Lifts Pvt.Ltd at their negotiated rates under Platinum Package, as furnished below, for a period of 3 years on expiry of the existing contract.
