ORDER

Sanction was accorded as per B.O. read 1st above, for conducting E-auction of trees along the 22m RoW across the Cheengeri Tribal Farm in connection with the construction of 66kV Substation Ambalavayal and entrusted the Chief Engineer (SCM) for the E-auction of trees using MSTC platform.The Chief Engineer, Transmission North as per letter read as 2nd above reported that, E-auction was conducted using M/s MSTC platform thrice and were rejected due to poor participation and low quoted rate. In view of the above, sanction was accorded as per B.O. read 3rd above, for conducting public auction for the disposal of trees in the presence of Tribal Department Officials.

The Chief Engineer, Transmission North as per letter read as 4th above reported that the public auction/ tender was conducted by the Executive Engineer, Transmission Division, Kaniyambatta on 28.10.2020 and wide publicity was given through the various Government Departments, LSGDs and official web site of KSEBL. Even though five tender forms were sold but no offer was received in time. Then the Deputy Chief Engineer, Transmission Circle Kozhikode, has conducted the auction with the officials of ITDP officers. Three bidders participated in the tender cum auction. The highest bidder Sri. James Emmanual, JE Timbers, Ambalavayal has offered an amount of Rs.13,62,000.00 (Rupees Thirteen lakhs and sixty two thousand only) against the assessed value of Rs. 36,89,302.00/-.

The Chief Engineer, Transmission North has requested to sanction to confirm the auction at 36.91% of the assessed value infavour of Sri. James Immanual, JE Timbers, Ambalavayal at his offered rate of Rs.13,62,000.00/-(Rupees Thirteen lakhs and sixty two thousand only)+ GST + Forest Development Tax + Income Tax on Timber.

The matter is placed before Full Time Directors as per note read as 5th above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 20.11.2020, Resolved to accord sanction to confirm the Tender cum auction conducted for the disposal of trees along the 22m RoW across the Cheengeri Tribal farm in connection with the construction of 66kV Substation Ambalavayal at 36.92% of the accessed value of Rs. 36,89,302.00/-with eligible taxes and duties in favour of Sri.James Immanual, JE Timbers, Ambalvayal at his offered rate of Rs.13,62,000/- (Rupees Thirteen lakhsand sixty two thousand only)+GST+Forest Development Tax+ Income Tax on Timber.

Orders are issued accordingly.
