## <u>ORDER</u>

The Chief Engineer (TransGrid) pointed out that for the smooth implementation of the projects and for streamlining the construction activities, a place of Deputy Chief Engineer may be deployed and posted in the Chief Engineer's Office urgently. Accordingly a Deputy Chief Engineer was posted at the Office of Chief Engineer (TransGrid) for a period of one year w.e.f 15.11.2019 as per B.0 read as 3<sup>rd</sup> above.

As the period of deployment was completed on 15.11.2020, the Chief Engineer (TransGrid) requested to extend the service of the Deputy Chief Engineer for a further period of one year w.e.f.15.11.2020. The Director (Transmission & System Operation) as per note read as  $4^{h}$  above pointed out the role of this Deputy Chief Engineer in testing and commissioning of the upcoming substations.

Having considered the matter, the Full Time Directors in the meeting held on 02.12.2020, 'Resolved to accord sanction to extend the period of the Deputy Chief Engineer, Office of the Chief Engineer (TransGrid), Shornur for one year with effect from 15.11.2020 as requested by the Chief Engineer (TransGrid).'
