ABSTRACT

Hiring a diesel jeep with driver on contract basis for the use of Transmission Construction Section Kannur – Sanction accorded - orders issued.

ORDER

Sanction was accorded as per B.O read as 1st above for hiring a diesel jeep with driver for the use of the Transmission Construction Section, Kannur with km ceiling of 1500km/month on contract basis for a period of one year or till the completion of the doubling work of 6.9km 110kV Pinarayi – Thalassery feeder, whichever is earlier. The sanctioned period of the contract vehicle with driver had expired on 19.04.2020.

The Chief Engineer, Transmission North as per note read as 2nd above has reported that 40 % of the doubling work of 110kV Pinarayi- Thalassery feeder is completed and was temporarly stopped due to water logged condition at site as well as COVID 19 lockdown. The work was restarted on 28.09.2020. The upgradation of 6.3 km 66kV SC line to 110kV DC from Kadachira to Chova tap and 6.5 km line upgradation work from Pinarayi Substation to Kadachira is also entrusted to the TC Section Kannur. For the speedy execution of the work and smooth functioning of the office , a vehicle in good condition is urgently required. Hence it was requested sanction to hire a diesel jeep with driver for the use of the Transmission Construction Section, Kannur for a period of one year or till the completion of the works, whichever is earlier.

The matter was placed before the Full Time Directors as per note read as 3rd above. Having considered the matter in detail, the Full Time Directors in the meeting held on 17.11.2020,

Resolved to accord sanction for hiring a vehicle (Diesel Jeep) with Driver on contract basis for the use of Transmission Construction Section Kannur with kilometer ceiling of 1500km per month, for a period of six months or till the completion of the works, whichever is earlier.
