ORDER

Sanction was accorded as per B.O. read as 1st above for hiring a vehicle (mini lorry below 5 T capacity) on contract basis for the use of Electrical Sub Division, Wadakkanchery under Electrical Circle, Thrissur with a monthly ceiling of 1,500 km for a period of six months for the smooth functioning of the office, by observing all formalities.

As per letter read as 2nd above, the Chief Engineer (Distribution Central), Ernakulam has reported that the contract period of the above lorry expires on 14/11/2020. There are 9 Sections under Electrical Division, Wadakkanchery and the Electrical Section, Thiruvilwamala is approximately 50 km from the Sub Regional Store, Thrissur. The works under 'Dyuthi' is progressing in a fast pace and the major portion of PMSU works are related to re-conductoring. The service of a mini lorry is essential for the transportation of materials and scrap in time. The present contractor has expressed his willingness to continue the contract for a further period of six months, with the same terms and conditions of the existing contract.

Considering the above and based on the request of the Deputy Chief Engineer, Electrical Circle, Thrissur, sanction has been accorded from the Office of the Chief Engineer (Distribution Central), Ernakulam to extend the contract period of the existing hired vehicle (mini lorry below 5 T capacity) attached to the Electrical Sub Division, Wadakkanchery for a period of six months from 14/11/2020 with a monthly ceiling of 1,500 km with the same terms and conditions of the existing contract for the smooth functioning of the office.

In the above circumstances, the Chief Engineer (Distribution Central), Ernakulam requested necessary ratification in the matter.

Accordingly, the matter was placed before the Full Time Directors as per note read as 3rd above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 20/11/2020 resolved to ratify the action of the Chief Engineer (Distribution Central), Ernakulam in having extended the contract of the existing hired vehicle (mini lorry below 5 T capacity) attached to Electrical Sub Division, Wadakkanchery for a period of six months with effect from 14/11/2020 at the same terms and conditions of existing contract.
