One Time Settlement Scheme (OTS-2021) – Proposal – Sanctioned - Orders issued.

ORDER

KSEBL as per the petition read as 1st above had approached the Hon'ble KSERC for extending the One Time Settlement Scheme (OTS-2019) upto 31.12.2019. The Hon'ble KSERC after conducting a public hearing on the petition had issued orders directing KSEBL for filing fresh proposal for One Time Settlement, if needed.

The extension of OTS-2019 was sought by KSEBL as there have been several requests from the consumers who availed OTS-2019 scheme that, in the wake of the Covid-19 pandemic they could not remit the settled amount within the stipulated time. Moreover, many fresh requests were received from Government institutions, Public Sector Undertakings, sick industries, self financing institutions etc for settling their arrears under OTS scheme. Hence, in order to mitigate the hardship faced by the consumers, the extension of OTS scheme was sought by KSEBL. However, in the light of the above directions issued by the Hon'ble Commission, the Deputy Chief Engineer (Commercial & Planning) as per the note read as 4th above has placed a fresh proposal for One Time Settlement before the Full Time Directors which is to be taken up with the Hon'ble KSERC for approval. It is also suggested for making necessary provisions in the Oruma software for extracting the details/reports of the OTS settled consumers from the software itself so that the same can be submitted before the Hon'ble Commission within the time limit.

Having considered the matter in detail, the Full Time Directors in the meeting held on 20.11.2020

- i) Resolved to approve the petition and scheme for One Time Settlement (OTS-2021) to be submitted before the Hon'ble Commission in compliance to Regulation 136(5) of Kerala Electricity Supply Code, 2014.
- ii) Further resolved to authorize the Deputy Secretary (Administration), KSEBL to issue a Demand draft/ Cheque for Rs 10,000/- (Ten thousand only) drawn in favour of the Secretary, KSERC, Vellayambalam, Thiruvananthapuram.
- iii) Further resolved to authorize the Chief Engineer (IT& CR) for making necessary provisions in the Oruma software for extracting the details/ report in respect of arrears settled under OTS scheme for submitting the same before the Hon'ble Commission, in the prescribed format within the stipulated time.

- iv) Also resolved to allow a special rate of interest for settlement of arrears which are more than 15 years old.

Orders are issued accordingly.
