ORDER

As per the B.O. read as 1st above, the rates for hiring motor cabs having cubic capacity 1500 cc and above have been enhanced to ₹17.00 per km. The Chief Engineers were permitted to sanction upto 10% extra over the basic rates for hiring vehicles only for the use of Offices of Executive Engineers, Deputy Chief Engineers and Chief Engineers, if vehicles were not available at the Government approved rates.

As per letter read as 3rd above, the Chief Engineer (Distribution South), Thiruvananthapuram has reported that sanction was given from that office as per proceedings read as 2nd above for hiring a vehicle with driver for the use of Electrical Section, Kazhakuttom under Electrical Circle, Thiruvananthapuram at the rate of ₹18.50 per km for the 24 hours use for a period of one year.

The Chief Engineer (Distribution South) has reported that by oversight, sanction was accorded from that office for hiring vehicle for Electrical Section, Kazhakuttom at the rate of ₹18.50 per km which was above the sanctioned rates of ₹17.00 per km.

In the circumstances, the Chief Engineer (Distribution South), Thiruvananthapuram has requested necessary ratification in his action of having awarded the contract for hiring vehicle for the use of Electrical Section, Kazhakuttom at the rate of ₹18.50 per km for 24 hours use.

The matter was placed before the Full Time Directors as per note read as 2nd above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 17/11/2020, resolved to ratify the action of the Chief Engineer (Distribution South), Thiruvananthapuram in having awarded the contract for hiring vehicle for the use of Electrical Section, Kazhakuttom under Electrical Circle, Thiruvananthapuram at the rate of ₹18.50 per
