Purchase of ACSR Rabbit Conductors from M/s. Traco Cable Co. Limited and Kerala based MSME's - Sanctioned – Orders issued.

ORDER

In the meeting held on 03/07/2019, chaired by the Hon'ble Ministers for Electricity and Industries, it was decided that KSEBL shall procure ACSR Conductors up to 19 strands from M/s. Traco Cable Co. Limited and Kerala based MSMEs at 55:45 proportion respectively at discovered rate as per last tender plus 10% price preference for two years.

Accordingly Purchase Orders were placed with M/s. Traco Cable Company Limited and 10 Kerala based MSME's for the supply of 9,740 km of ACSR Raccoon and 39,659 km of ACSR Rabbit in the ratio 55:45 respectively vide Purchase Orders dated 23/11/2019 at the discovered rate as per last tender plus 10% price preference on basic price with IEEMA price variation as per Government decision. The Government Order was issued on 07/03/2020 regarding the same decision.

As per Purchase Plan 2020-21, the total requirement of ACSR Rabbit is 87,817 km, i.e., the monthly requirement will be 7318 km.

Vide letter read as 7th above, the Director (Distribution, IT & HRM) has informed that 93925 km ACSR Rabbit Conductors are required from July 2020 to March 2021 for the execution of Distribution works.

The Director (G-E&SCM) has suggested for procuring 45800km ACSR Rabbit conductors since the production capacity of 10 MSMEs up to March 2021 is 12,000 km, and for M/s.Traco Cable Company Ltd, up to March 2021 is 33,800km. Considering the total requirement of 75,925km ACSR Rabbit Conductors, the Director (G-E&SCM) has also suggested to invite open tender for the balance quantity of 30,125km.

Since the existing pipeline quantity is not sufficient to meet the requirement for the execution of targeted, maintenance/ breakdown works and the item is a fast moving one, the availability of conductor is to be ensured for the coming months. Hence it is recommended to place purchase orders with M/s.Traco Cable Company Limited and MSME's (10 firms) at the existing Purchase Order rate and same terms & conditions of the Original Purchase Order dated 23/11/2019 for the supply of 45,800km ACSR Rabbit Conductors.

The matter was placed before the Board of Directors as per Note read as 8th above for decision.

Having considered the matter in detail, Board of Directors in its meeting held on 14/10/2020 resolved to authorize the Chief Engineer (SCM) for placing Purchase Order with the existing suppliers of M/s.Traco Cable Company Ltd (Government PSU) and the Kerala based MSMEs (10 MSMEs) on completion of supply, considering their monthly production capacity at the existing Purchase Order rate (discovered rate as per last tender plus 10% Price Preference on basic price) with IEEMA Price Variation for the supply of 45800km of ACSR Rabbit Conductors after exploring possibility of additional procurement without price escalation. Total financial commitment will be Rs.193.25Crore approximately (Rupees One Hundred Ninety Three Crore and Twenty Five Lakh only).

Orders are issued accordingly.


