ORDER

M/s.Nalakath Granites, Velamboor, Malappuram, HT Consumer had remitted an amount of Rs.5,00,000/-(Rupees Five lakh only) vide receipt No. 102006 on 15.03.2018 for the registration of the proposed 500 kWp Solar plant in Electrical Section, Pattikkad- Chungam, but couldn't complete the plant in time and the HT Consumer later proposed to upgrade the Solar Project capacity to 1MWp and requested that the total amount to be remitted for registration for the 1 MWp Solar plant to be adjusted from registration fee from the the already remitted amount for the initially proposed 500 kWp Solar plant and the balance will be remitted by the consumer.

As per BO read (2) above the adjustment in registration fee was approved and the consumer remitted the balance amount of Rs.5.9 Lakh on 09.09.2019 vide receipt no. 40300 in Electrical Section, Pattikkad-Chungam and total amount remitted for the registration for the 1 MWp Solar plant was Rs.10.9 Lakh.

The installation work of the proposed 1 MWp Solar plant is in progress now and the consumer has requested to extend the registration up to 31.12.2020; citing technical reasons.

As the work is in progress & due to the restrictions in place due to Covid 19 Panademic; the request of the consumer can be considered favourably.

As per the Assistant Engineer, Electrical Section, Pattikkad-Chungam, no other consumer had applied for solar connectivity in this feeder till date

The Chief Engineer (Renewable Energy & Energy Savings), vide the note read as paper 5 above, has further recommended to extend re-registration of M/S. Nalakath Granites, since it will not block the opportunity of any other consumers for solar connectivity registration. Having considered the matter in detail above, the Full Time Directors in the meeting held on 04.11.2020.

- 1. Resolved to accord sanction to consider the request of the consumer M/s.Nalakath Granites, Velamboor, Malappuram to extend the registration up to 31.12.2020..
- 2. Further resolved to authorize the Deputy Chief Engineer (Commercial & Planning) with full power of the Chief Engineer to get the above ratified from the KSERC.
