<u>ORDER</u>

The Chief Engineer (Civil -Dam Safety &DRIP) had invited e-tender for the CC TV Surveillance of DRIP dams as per World Bank Guidelines and as per BO read as 1st, sanction was accorded to appoint Sri. R. Srinivasan, Programme Head, ICFOSS, Sri Ajith A.P, Deputy Executive Engineer, PWD Electronics Division, Thiruvananthapuram, Dr. Pradeep.R, Associate Professor, Barton Hill Government Engineering College, Trivandrum and Sri. Manoj Mathew Kuriakose, Assistant Executive Engineer, IT & Computerisation Unit as members in the SPMU level technical committee for the technical scrutiny, evaluation and qualification of the bids received for the tender "DRIP-Supply, Installation, Testing, Commissioning, Training and maintenance of CC TV surveillance system at 16 selected dam sites of KSEB Ltd including a Central Control Center at Pallom" and for evolving suggestions/recommendations to SPMU. Sanction was also accorded to pay a consultation fee of Rs. 5000/-per sitting in addition to the TA and DA at the applicable rates eligible for Grade I officers of KSEBL to the External members Sri. R. Srinivasan, Sri Ajith A.P and Dr. Pradeep.R.

The Chief Engineer (Civil -Dam Safety &DRIP) executed Agreement for the subject work Agreement Thiruvananthapuram as Limited, M/S Adtech Systems with No.01/CE(C)/DS/DRIP/PLM/2020-21 dated 29.04.2020 . It is informed as per note read as 2nd above that the work is progressing at 16 dam sites and the contractor has proposed certain changes to a few items to be supplied and a decision has to be conveyed to the contractor. As the subject work is of specialized nature, the Chief Engineer recommends to form a Technical Advisory Committee with experts in the field of industry and technology for fulfilling the intended objectives as per the scope of contract agreement. It is also added that the Committee members shall oversee and ensure that the execution of the works and supply of goods made by the contractor are conforming to the quality standards stipulated in the contract agreement and the committee shall provide necessary technical advice to KSEBL for the smooth progress and timely

The Chief Engineer (Civil -Dam Safety &DRIP) has suggested the following members in the Technical Advisory Committee who had actively participated in the committee constituted for technical scrutiny and evaluation of bids for the subject work.

It is also recommended to fix the consultation fee eligible for the external experts as Rs. 5000/-per sitting in addition to TA & DA at applicable rates eligible for Grade I officers of KSEBL.

The matter was placed before the Full Time Directors as per note read as 3rd above. Having considered the matter in detail, the Full Time Directors in the meeting held on 04.11.2020 resolved to accord sanction to constitute a Technical Advisory Committee for the work "DRIP- Supply, Installation, Testing, Commissioning, Training and maintenance of CC TV surveillance system at 16 selected dam sites of KSEB Ltd. including a Central Control Center at Pallom" with the following members:

Further resolved to pay a consultation fee of Rs. 5000/-per sitting in addition to TA &DA at applicable rates eligible for Grade I officers of KSEBL, to the external member Sri. R. Srinivasan .
