#### ORDER

The Deputy Chief Engineer, Electrical Circle, Thiruvananthapuram as per letter read as 5<sup>th</sup> above has sought ratification on the steps taken to implement the decision taken in the Janakeeya Adalath, to settle the pole rental arrears of M/s. Our Cable TV Network, Chirayinkeezhu under Electrical Division, Attingal. An amount of Rs.4,48,998/- (Rupees Four lakh forty eight thousand nine hundred and ninety eight only) was outstanding against M/s. Our Cable TV Network, Chirayinkeezhu towards arrears of pole rent and

other charges such as interest, GST, Cess etc. for the period\_from 2011-12 to 2019-20. The Operator, Our Cable TV Network as per letter read as 2<sup>nd</sup> above has requested to consider his arrears under the Janakeeya Vydyuthi Adalath 2020. In this connection, the Executive Engineer, Electrical Division, Attingal has clarified that Mr. Rajmohan, Our Cable TV Network under Electrical Section, Chirayinkeezhu has submitted application to the Janakeeya Adalath dated 20.01.2020 for the arrear settlement of his pole rent with effect from 25.10.2016, but the KSEBL has ascertained and assessed his pole rent arrear from 2011-12 to 2019-20.

As per the decision of the Janakeeya Vydyuthi Adalath held on 19.02.2020, the Director (Distribution, IT & HRM) of KSEBL has directed to revise and re-assess the pole rent arrear of Mr. Rajmohan, Our Cable TV Network with effect from 25.10.2016, from the date of obtaining license, with the supporting document of duplicate postal registration Certificate (Reg. No. 460) received from the Postal Department, Attingal and to settle the arrear in four instalments. The Operator has remitted the re-assessed amount of Rs.1,47,825/-( Rupees One Lakh Forty Seven Thousand Eight Hundred and Twenty Five Only) in one lump on 17.03.2020. Subsequently, the Deputy Chief Engineer, Electrical Circle, Thiruvananthapuram has requested to accord ratification on the steps taken to implement the decision taken in the Janakeeya Adalath.

The matter was placed before the Full Time Directors as per the note read as 9<sup>th</sup> above. Having examined the matter in detail, the Full Time Directors in the meeting held on 04.11.2020, resolved to ratify the action of the Deputy Chief Engineer, Electrical Circle, Thiruvananthapuram, in having taken steps to regularize the pole rental arrears due from Sri. Rajmohan, M/s. Our Cable TV Network, Chirayinkeezhu, in accordance with the decision of the Janakeeya Vydyuthi Adalath 2020, held on 19.02.2020.
