**ORDER**

M/s. NLC India Limited (NLCIL), as per letter read (2) above, had requested KSEB Ltd. to give consent to sell the Un Requisitioned Surplus (URS) power of KSEB Ltd. in NLCIL Power Station Neyveli New Neyveli Power Plant (NNTPP) in market with effect from 01.10.2020.

The Chief Engineer (Transmission & System Operation) had recommended to give NOC for sale of URS power of KSEB Ltd. in NNTPP, in line with the tariff policy notified by MoP on 28.01.2016 subject to the following conditions.

1. The daily request for URS sale will be considered on a case to case basis based on the day wise Load Generation Balance so as to ensure economic operation of KSEBL.
2. The generator shall ensure that the sale of power in the exchange is at a rate not less than the variable cost of the station.

The matter was placed before the Full Time Directors as per note read (3) above, and the Full Time Directors in the meeting held on 04.11.2020, resolved to

accord sanction to issue No Objection Certificate to NLCIL for sale of URS power of KSEB Ltd. from New Neyveli Thermal Power Plant (NNTPP) of NLCIL in market through Power Exchange for the quantum surrendered at least 24 hours before 00.00 hours of the day as per the provisions of revised tariff policy notified by MoP on 28.01.2016 as recommended by the Chief Engineer (Transmission System Operation), subject to the condition that the generator shall ensure that the sale of power in the exchange is at a rate not less than the variable cost of the station.

Orders are issued accordingly.


