## **ORDER**

M/s. Athulya Cements (P) Ltd. was a High Tension consumer having LCN 17/1742. The consumer came under the jurisdiction of the Deputy Chief Engineer, Electrical Circle, Palakkad.

As the consumer defaulted in the payment of current charge arrears, the service connection was disconnected on 19.11.2002 and later dismantled on 01.12.2003. Hence, revenue recovery requisition was made on January 2004 for an amount of ₹ 31,04,716/- (including interest).

As per the letter read as 1<sup>st</sup> above, the Tahasildar, Palakkad has informed that there is no scope for recovery.

The Director (Finance), KSEBL has directed to obtain a legal opinion from the Legal Advisor & Disciplinary Enquiry Officer, KSEBL. As per note read as 3<sup>rd</sup> above, the Legal Advisor & Disciplinary Enquiry Officer has opined that as the

Company was registered under the Companies Act, it has only limited liability and so that all debts incurred by the Company are the Company's liability and are not the legal liabilities of the share holders or of the Directors of the Company. It was advised that as all the properties of the Company are said to have been auctioned under Revenue Recovery proceedings as early as on 28.10.2004, further scope for realization of the arrear is bleak. Hence the matter was reffered for a Vigilance Enquiry to find out whether the Company had cheated KSEBL by committing fraud and to examine the scope of Revenue Recovery action. The Vigilance enquiry which is read as 2<sup>nd</sup> above has exposed that neither the Company nor its owner has any movable or immovable property in their name?

Hence, the matter was placed before Full Time Directors in its meeting held on 26.08.2020 for a direction to write off the arrear amount of ₹ 19,66,843/- and in the meeting it was directed to place the matter before the Director Board.

Accordingly the matter was placed before the Director Board as per note read 6<sup>th</sup> above. The Director Board in its meeting held on 14.10.2020 resolved to write off the amount of ₹ 19,66,843/- (Rupees Nineteen Lakh Sixty Six Thousand Eight Hundred and Forty Three Only) (Principal), which is due from M/s. Athulya Cements (P) Ltd. and be withdrawn from the accounts.

Orders are issued accordingly.
