ORDER

KSEBL is in the process of setting up of around 250 Charging Stations across Kerala under various Government Schemes. As part of it, under Phase I, installation of six charging stations in the six corporations on State scheme are completed and minor works related to payment gateway and Mobile App (IT works) are only pending. The commercial operation of the following stations is also expected to be started by November 2020.

The project is being carried out on 100% GoK subsidy and is located on the land owned by KSEBL. Once the EV charging stations are made open to public, KSEBL has to announce an appropriate "Service Charge" for charging the Electric Vehicle.

Based on the BO read 2 above, a chart has been prepared for the service charge for almost all the vehicles currently under use in India (except heavy vehicle). The service charge is prepared as a fee for full charging of the battery of the vehicle concerned. However, the customer can have their own freedom of choice for full, half, quarter or top up charge as required and service charge will be levied according to the apportion of the full charge. Any GST applicable to the above will also be charged as per the rules.

As per the BO read 2 above an offer (first year, second & third years and fourth year onwards) has been released to the property owner related to handing over of the land to KSEBL on right to use basis for the installation of the EVCS on their premises. It is advisable to provide an early bird offer of free of service charge to all customers for the first three months of operation of the above stations to spread awareness and switch over more people to electric vehicles.

The chief Engineer (REES) as per the note read as 3rd above requested sanction to levy the service charge as per the chart furnished above and also to make the service charge free as an early bird offer, for the first three months from operation, for all customers, to spread awareness and switch over more people to EVs. The Chairman and Managing Director has directed to put up the proposal before the Full Time Directors.

Having considered the matter in detail, the Full Time Directors in its meeting held on 09.10.2020

- 1. Resolved to waive the service charge to all customers, for the first three months from operation to promote Electric Vehicles in the State.
- 2. Further resolved to levy service charge from the customer as per the chart below after three months from operation
