### ORDER

M/s. Perfect Alloys, Chengannur is an HT consumer of Electrical Section, Chengannur under Electrical Circle, Harippad with LCN 26/5712. The service connection to the premises of M/s. Perfect Alloys was disconnected on 18.03.2019 due to non-remittance of current charge from 04/2018. The accumulated outstanding arrear towards non-remittance of current charge comes to ₹ 20,52,788/- (including interest for belated payment) as on 20.02.2020. The Security Deposit available at credit of the service connection is ₹ 5,78,870/- which is not sufficient to adjust the arrear amount. Subsequently, an arrear notice was issued to the consumer from the office of the Special Officer (Revenue) through the Deputy Chief Engineer, Electrical Circle, Harippad as a prelude to dismantle the service connection. The consumer has not remitted the arrear in spite of being issued with statutory dismantling notice by the Deputy Chief Engineer concerned. Instead, upon receipt of the last dismantling notice, the consumer has requested to settle the arrear in Vidyuthi Adalath proposed at the District level at Alappuzha.

In Alappuzha District Vidyuthi Revenue Adalath held on 19.02.2020, it was decided to reduce the Contract Demand of the service connection to 100 KVA from the existing 230 KVA with effect from 18.06.2019 (i.e., after 3 months from the date of physical disconnection) and revising the demand charges accordingly. It was also decided to allow 5 equal monthly installments to clear the revised arrear amount. The Agreement Authority did not physically

dismantle the service connection following the expiry of the statutory time limit of dismantling notice and even after the date of Adalath due to the repeated request of the consumer to hold the service connection. Whereas the service connection has been physically dismantled on 07.07.2020 upon receipt of a request from the consumer.

In order to finalize the revenue arrears due from the defaulted consumer a pertinent issue was raised by the Special Officer (Revenue) as to whether the reduced contract demand charge for 100 KvA as per Adalath decision may have to be continued upto the date of dismantling.

The matter was placed before the Director (Distribution & IT) as per the note read (3) above and the same was submitted to the Chairman & Managing Director, KSEBL for a decision. The Chairman & Managing Director, KSEBL has directed the Special Officer (Revenue) to place the matter before the Full Time Directors. Accordingly the matter was placed before the Full Time Directors as per note read as 5<sup>th</sup> above.

Having examined the matter in detail, the Full Time Directors meeting held on 01.10.2020 resolved to go strictly as per Regulation 141 due to non-compliance of Adalath decision.

Orders are issued accordingly.
