Proposal for functioning of an additional Breakdown Unit at Parappa for resolving the prolonged power interruption issues at Parappa and nearby areas under Electrical Section – Rajapuram under Electrical Circle, Kasaragod - Sanctioned - Orders issued.

## **ORDER**

Sri. P Karunakaran (former MP), as per letter read as 1<sup>st</sup> above, has requested to consider the resolution passed by the Kinanoor Karinthalam Grama Panchayath for the formation of New Electrical Section office at Parappa in Kinanoor Karinthalam Grama Panchayath. The Hon'ble Minister for Electricity has directed to examine the possibility of starting new Electrical Section at Parappa or at least to start a new Breakdown wing under Electrical Section – Rajapuram to resolve the issues due to prolonged interruptions at Parappa and nearby areas.

The Deputy Chief Engineer, Electrical Circle, Kasaragod as per letter read as 2<sup>nd</sup> above reported that the distance between Parappa and the existing Head Quarters of Electrical Section Rajapuram is about 12 kilometers. The supply interruption complaints at Parappa area are on the higher side due to thick vegetation and hilly terrain area and so is the time for restoration, as the transportation facility in the area is also scanty.

In a similar situation, to resolve the supply interruption issues of Malakkappara area, under Electrical Section Pariyaram, located far away from the Section Headquarters, sanction had been issued for functioning of an additional breakdown Unit with a vehicle.

The Director (Distribution, IT & HRM), as per note read as 3<sup>rd</sup> above, suggested to start an additional Breakdown Unit with vehicle and CUG facility (to contact consumers, office

and higher officers) to resolve the prolonged power interruption issues at Parappa and nearby areas. Having considered the matter in detail, the Full Time Directors of the Board in its meeting held on 04.11.2020, resolved to accord sanction for the following.

- For the functioning of an additional Breakdown Unit in a room to be provided by KinanoorKarinthalam Grama Panchayath, free of rent with staff pattern as shown below and with vehicle and CUG facility to resolve the prolonged power interruption issues at Parappa and nearby areas under Electrical Section, Rajapuram of Electrical Circle, Kasaragod.
- 2. To authorize Chief Engineer (HRM) to post staff as per Table given below to newly formed Breakdown Unit through deployment.

- To authorize the Deputy Chief Engineer, Electrical Circle, Kasaragod to hire a
  vehicle for use in the newly formed Breakdown Unit and to re-fix the monthly
  ceiling for the hired vehicle in the parent Section accordingly.
- 4. To provide a CUG SIM with outgoing call facility to the newly formed Breakdown Unit, to contact consumers, Section Office and higher offices.
