ORDER

Aiming at Consumer's satisfaction, KSEBL as per order read as 1st above had accorded sanction to conduct Vydyuthi Adalath 2020 at all the District Accordingly, Adalaths were conducted at the district headquarters. headquarters from 11.01.2020 to 27.02.2020 to settle the complaints of EHT, HT and LT consumers.

Altogether 72 complaints with various issues were received from the HT consumers. Out of the 72 complaints, 30 complaints were fully settled as per Adalath decisions. Of the remaining 42 complaints, 12 complaints are under processing. In the case of 30 complaints, KSEBL had taken necessary actions as per the Adalath decisions, but the consumers had not complied the Adalath decision and had committed default in payment of sanctioned installments, non-withdrawal of Court cases, non-remittance of sanctioned OTS, etc.

As per Adalath decision, a total amount of ₹ 31,94,809/- (Rupees Thirty One Lakh Ninety Four Thousand Eight Hundred and Nine only) was withdrawn / adjusted from system ENRGISE against the following 8 consumers.
