### **ORDER**

Dr Dinesh Arora, IAS, Secretary, Power Department, Government of Kerala, as per letter read as 1<sup>st</sup> above requested urgent action to install a lamp post and street light at the end of the Arappura valley by lane road in Trivandrum Corporation, since the absence of streetlight is causing difficulties to early morning walkers and people who return home late.

The Executive Engineer, Electrical Division, Thiruvananthapuram as per letter read as 2<sup>nd</sup> above reported that the work of replacement of 40 LED street lights in the above location is being carried out, but for addressing the issue in the letter from the Secretary, Power, two LED streetlights are required and 1 span street main is to be constructed, at an estimate cost of ₹ 17,910/-. It was also reported that since the drawing of street main and installation of streetlights come under the purview of the local body, the matter had been taken up with the Councilor of the Vattiyoorkkavu ward of the Thiruvananthapuram Corporation so that the Corporation may deposit the amount to KSEBL, and that in case the beneficiary wished to avoid the procedural delay from the Corporation, Thiruvananthapuram, the beneficiary had to remit the above amount.

The matter of giving sanction to the Executive Engineer, Electrical Division, Thiruvananthapuram to carry out the work, in anticipation of remittance of the estimate amount on work deposit, from the Corporation, was placed before the Chairman & Managing

Director, and the Chairman & Managing Director decided to place the matter before the FTDs.

Accordingly, the matter was placed before the Full Time Directors as per note read as 3<sup>rd</sup> above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 14/10/2020, resolved to accord sanction to the Executive Engineer, Electrical Division, Thiruvananthapuram, to carry out the work of installing new LED streetlight fittings by drawing new line near Saraswathy Temple, Arappura, under Electrical Section, Vattiyoorkkavu, at an estimate cost of ₹ 17,910/-, in anticipation of remittance of the estimate amount on work deposit from the Corporation, and to take steps to start billing the street lights after installation, with the approval of the Secretary, Thiruvananthapuram Corporation.

Orders are issued accordingly.
