## ORDER

As per B.O. read as 1<sup>st</sup> above, sanction was accorded for the formation of 30 new Electrical Sections including Electrical Section at Lakkidi-Koottupatha. The B.O. has entrusted the Deputy Chief Engineer of Electrical Circles to explore the possibility of obtaining suitable building free of rent or minimum 10 cents of land free of cost for constructing the building to accommodate the new offices and to make alternate arrangements till the above materialize by requesting the authorities of local bodies in the respective area to provide rent free accommodation for the newly formed Electrical Sections. Also it was directed that the new sections be made functional as and when land is made available as above or rent free accommodation is provided.

As per letter read as 2<sup>nd</sup> above, the Chief Engineer (Distribution North), Kozhikode reported that the Lakkidi Perur Grama Panchayat had passed a resolution on 03/12/2018 to hand over 10 cents of land under the ownership of the Grama Panchayat to KSEB Ltd at free of cost for construction of building for Electrical Section, Lakkidi – Koottupatha and till then the Grama Panchayat will pay a monthly rent of ₹15,000/- for the building of Sri. Mohanakrishnan Odash, Sreelakam, Mangalam P.O., Lakkidi for accommodating the Section.

As per letter read as 3<sup>rd</sup> above, the Deputy Chief Engineer, Electrical Circle, Shoranur has reported that the owner of the proposed building for accommodating the newly formed Electrical Section, Lakkidi-Koottupatha had given his willingness to rent out the rooms with numbers 18/114, 18/115, 18/116 in his building (No.18/113) located in ward 18 of Lakkidi Perur

Grama Panchayat. The rent of ₹15,000/- for the building will be paid by the Lakkidi Perur Grama Panchayat. The building is at Lakkidi-Koottupatha, near the highway and is easily accessible. Vehicle parking and material stacking are manageable till the construction of new building in the land offered by the Lakkidi Perur Grama Panchayat. Further, the Lakkidi Perur Grama Panchayat had taken steps to hand over the 10 cents of land to KSEB Ltd for the construction of building for Electrical Section, Lakkidi-Koottupatha.

The new Electrical Section at Lakkidi was inaugurated on 05/10/2020 and had commenced its functioning in the rented building owned by Sri. Mohanakrishnan Odath.

The matter was placed before the Full Time Directors as per note read as 5<sup>th</sup> above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 14/10/2020 resolved to ratify the action in having commenced the functioning of the newly formed Electrical Section, Lakkidi-Koottupatha in the rooms with numbers 18/114, 18/115, 18/116 in the building bearing No. 18/113, located in ward 18 of Lakkidi Perur Grama Panchayat owned by Sri. Mohanakrishnan Odath, Sreelakam, Mangalam P.O., Lakkidi with rent being paid by the Lakkidi Perur Grama Panchayat till a building is constructed in the land offered by Lakkidi Perur Grama Panchayat.

Orders are issued accordingly.
