ORDER

As per B.O read as 1st above, sanction was accorded to conduct E-auction for the disposal of trees along the 22m RoW across the Cheengeri Tribal Farm in connection with the construction of 66kV Substation at Ambalavayal and entrusted the Chief Engineer (SCM) with the E-auction of the trees using the MSTC platform.

The Chief Engineer, Transmission North as per letter read as 2nd above has reported that, E-auction was conducted using MSTC platform thrice. The details of E-auction are as follows

In view of the urgency of the work and by considering the fact that the work was E-auctioned thrice, the Chief Engineer, Transmission North has requested sanction for conducting Local Auction for the disposal of trees in the 22m RoW across the Cheengeri Tribal Farm- land owned by ITDP . Also requested to entrust the Deputy Chief Engineer, Transmission Circle, Kozhikode ,Nallalam for conducting the local auction in the presence of Tribal Department Officials.

The matter was placed before the Full Time Directors as per note read as 3rd above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 09.10.2020, resolved to accord sanction to conduct local auction for cutting trees in RoW of the line route in the land owned by ITDP, whose assessed value is Rs.42,63,873.00/-

Further resolve to entrust the Deputy Chief Engineer, Transmission Circle, Kozhikkode, Nallalam for conducting the local auction in the presence of Tribal Departmental officials.
