ORDER
The construction of Edamon-Kochi 400 kV Transmission Line passing through 4 districts viz, Ernakulam, Kottayam, Pathanamthitta and Kollam, having 148.3 km length and 447 towers, which has been completed and the line energized on 25.09.2019. The disbursement of compensation for Tower Standing Area(TSA), Line Corridor and Trees/Crops damages are in progress. The Detailed Valuation Statement (DVS) for 421 tower locations ( 797 holdings) for an amount of Rs. 41.23 crores has been approved by the District Collectors as on 31.07.2020. An amount of Rs. 36.969 crores has been disbursed to 650 land owners towards TSA compensation by the LA Units at the above 4 districts. The Compensation for trees \& crops are issuing exclusively by PGCIL. Also an amount of Rs. 3.95 Cr . has been disbursed among 125 land holders as line corridor compensation.

The assessment of corridor compensation is in progress. The DVS has been approved for 118 spans out of a total of 446 spans for an amount of Rs. 54.359 crores.

The status of the assessment of compensation, disbursement of compensation and the particulars of the fund deposited by KSEBL etc. as on 31.07.2020 are detailed below.

- An amount of Rs. 12 Crores had been deposited by KSEBL towards line corridor (LC) compensation out of the total share of KSEBL/GoK against the share of Rs. 33.974 crores till now and a balance amount of Rs. 21.974 Crores is to be deposited.
- Also an amount of Rs. 6 crores had been deposited by KSEBL towards Tower standing compensation and a balance amount of Rs. 18.5 lakhs is to be deposited towards TSA compensation as on 31.07.2020.
c. As per the G.O.(MS.) No. 29/2015/PD Dated 30.07.15, Clause(X), "In the first instance, the amount for implementing the special compensation package will be met by KSEB by availing loan. Government share will be granted subsequently". Accordingly an amount of Rs. 9 Cr (Rs. $6 \mathrm{Cr}+\mathrm{Rs} .3 \mathrm{Cr}$ ) is to be received from Government of Kerala as the share of LC and TSA compensations.

Also as per the Board Order read 5 above, an amount of 155 Cr . is estimated as KSEBL's share and allocated for the purpose.

In view of the above, the Director(Transmission \& System Operation has'recommended to allocate an amount of Rs. 22 Cr . from KSEB fund for disbursement of the special compensation package for line corridor part, and the same may be transferred immediately to the Compensation Disbursement Accounts of "Edamon -Kochi Project" through ARU of Transmission Division Pathanamthitta. Accordingly the Government of Kerala share will be $20 \mathrm{Cr}(9 \mathrm{Cr}+11 \mathrm{Cr}$ ).
Having considered the matter in detail, the Full Time Directors in the meeting held on 17.09.2020,

1. Resolved to accord sanction to allocate an amount of Rs. 22 Cr. from KSEBL fund as per the Board Order dated 07.05 .2018 for disbursement of the special compensation package for Line Corridor part and to transfer the amount to the Compensation Disbursement Accounts of " Edamon - Kochi Project" through ARU of Transmission Division Pathanamthitta.
2. Further resolved to request the Government to allocate their share of Rs. 20 Cr . (including the earlier shares) on the above for meeting subsequent payments required in this regard.

Orders are issued accordingly.
