## ORDER

The Chief Engineer (Distribution Central), Ernakulam as per letter read as 1<sup>st</sup> above has reported the Electrical Division, Kodungallur under Electrical Circle, Irinjalakuda is having 10 Electrical Sections, around 1,80,000 consumers and has a vast area under its jurisdiction. The Division is having 2 lorries – a departmental lorry and a hired one. The departmental lorry attached to the Electrical Sub Division, Perinjanam was survey reported. Hence the hired lorry was fully engaged for the requirements of various Sections under the Division. Considering the difficulty in availing the vehicle for the requirements of all the Sections, the Deputy Chief Engineer, Electrical Circle, Irinjalakuda arranged a lorry of 5T capacity for the Electrical Division, Kodungallur for a period of six months @ ₹33/- per km with a monthly limit of 1,500 km and agreement was executed with Sri. Shaiju V.G., Venthalakkaran (H), Pariyaram, Chalakkudy. It is reported that now the Deputy Chief Engineer, Electrical Circle, Irinjalakuda has requested to extend the period of contract of the hired lorry for a further period of six months with the same terms and conditions of the existing contract.

Considering the request, sanction was accorded by the Chief Engineer (Distribution Central), Ernakulam to extend the above contract with the same terms and conditions for a further period of six months with effect from 01/08/2020.

In the above circumstances, the Chief Engineer (Distribution Central), Ernakulam requested ratification in the action of having extended the contract of the 5 T capacity lorry hired for Electrical Division, Kodungallur for a period of six months with effect from 01/08/2020 with the same terms and conditions of the previous contract.

The matter was placed before the Full Time Directors as per note read as 2<sup>nd</sup> above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 17/09/2020 resolved to ratify the action of the Chief Engineer (Distribution Central), Ernakulam in having extended the contract of the 5T capacity lorry hired for Electrical Division, Kodungallur for a period of six months with effect from 01/08/2020 at the same terms and conditions of previous contract.

Orders are issued accordingly.
