ORDER

As per letter read as 1st above, the Chief Engineer (Distribution North), Kozhikode has reported that Electrical Section, Kunissery under Electrical Division, Alathur started functioning in a rent free building of Erimayur Grama Panchayat with effect from 23/12/2006. The building is having only a space of 50 m². The staff and officers are hardly surviving in the minimum area provided. Even the sunrise meeting cannot be properly conducted due to lack of space. The billing section and cash counters are accommodated in a shabby and congested manner. There is no space for the consumers to wait. The staff of Electrical Section, Kunissery are requesting to shift the office to a convenient place for a long time. The Section has maintained 100% collection efficiency for the period from 01/2012 to 02/2020 until the COVID 19 period.

Several enquiries were made in the previous years to shift the office to a convenient building at affordable rent. But no suitable buildings were available. Now, M/s BSNL has offered their exchange building having a plinth area of 90 m² at a monthly rent of ₹13,000/-.

In the above circumstances, the Chief Engineer (Distribution North), Kozhikode requested sanction for shifting Electrical Section, Kunissery to the BSNL building with a monthly rent of ₹13,000/-.

The matter was placed before the Full Time Directors as per note read as 2nd above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 17/09/2020 resolved to accord sanction for the following:

1. For shifting the office of Electrical Section, Kunissery under Electrical Circle, Palakkad to building owned by M/s BSNL.
2. For paying a monthly rent of ₹13,000/- for the building with effect from the date of occupation.

Orders are issued accordingly.
