ORDER

The contract for the balance works of the construction of concrete lined power tunnel from Adit V for Kakkad Hydro Electric Project was entrusted to M/s. Paily Pillai & Sons. Following a dispute with KSEBL, M/s. Paily Pillai & Sons had filed a petition before the Hon'ble High Court and in the W.P. (C) No. 15940 of 2009 dated 04.01.2018**Sd/-**, the Hon'ble High Court directed the Board to reconsider the matter afresh after affording opportunity to the petitioner, in a time bound manner, at any rate within three months from the date of receipt of a copy of the judgment.

The Chief Engineer (Civil) Construction-South heard the petitioner and the facts thereof were reported as per note read 2 above. Then it was directed by the Chairman & Managing Director to issue a Speaking Order to the Contractor based on the hearing.

The Chief Engineer as per note read as 3rd above has requested for the approval of the draft Speaking Order declining the claims of the Contractor M/s. Paily Pillai & Sons, duly considering the agreement conditions, relevant Board Orders and Court Orders as given in Annexure.

The proposal was placed before the Full Time Directors as per note read as 4th above.

17.09.2020,resolved to approve the draft Speaking Order of the Chief Engineer (Civil) Construction-South declining the claims of the Contractor M/s. Paily Pillai & Sons, duly considering the agreement conditions, relevant Board Orders and Court Orders as given in Annexure .

The Chief Engineer(Civil) Construction-South shall take further necessary action in this regard.
