TransGrid 2.0- Adopting PRICE software for KSEBL transmission line works – orders issued.

ORDER

The Government of Kerala had accorded Administrative Sanction for the TransGrid 2.0 project amounting to Rs 6375 crores and KIIFB has conditionally approved projects worth Rs 5200 crores. A tripartite agreement was signed on 17th July 2017 between KSEBL, Government of Kerala and KIIFB. As per the G.O read as 3rd above, the Government has issued guidelines for ensuring necessary standardization and efficiency in preparation, processing and implementation of proposals of projects funded by KIIFB. As part of this, the estimate rates adopted in the TS shall be as per PRICE software used in Government of Kerala.

Once the estimates are prepared using PRICE, LMR justification is generated by the system itself, if the data inputs are given. KIIFB has mandated the LMR justification generated through PRICE software in all KIIFB assisted projects of KSEBL works for all tender acceptances with effect from 01.09.2020. Moreover, KIIFB has insisted for adopting the KIIFB guidelines and the prevailing Government orders/norms for the future project implementations.

KSEBL has adopted the PRICE software as per BO read 4th above, for civil works, as per the Government letter No. 2853/Ind & PW.B2/14/fin dated 31.01.2017 and authorized the Chief Engineer (Civil-Investigation & Construction central) to take further necessary actions in this regard. CPWD data and CPWD SOR are adopted in PRICE software but the data for electrical works are not included in PRICE.

Hence the Chief Engineer (TransGrid) requested for adopting PRICE software for transmission line and substation works also in KSEBL so that the LMR justification can be done through this software for tender acceptance. The Director (Transmission, System Operation &REES) as per note read as (5) above, placed the matter before Full Time Directors. Having considered the matter in detail, the Full Time Directors in the meeting held on 09.09.2020,

Resolved to accord sanction to adopt PRICE software in transmission works and to incorporate the approved Transmission data in the PRICE software for the preparation of estimates of all works related to transmission including TransGrid works.

Further Resolved to entrust the O/o the Chief Engineer, TransGrid with the task of incorporating the data in PRICE software after formation of a Committee with representatives from the O/o Chief Engineer (Transmission South), O/o Chief Engineer (Transmission North) and Chief Engineer (Civil Construction), South.

Orders are issued accordingly.
