ORDER

Sri. Renjithkumar R. Panchami (H), Peroor Road, Ettumanoor filed a petition in the District Level Vydyuthi Adalath conducted in January 2020 at Kottayam for shifting of 11kV line passing through his property lying within the area of Electrical Section, Ettumanoor, which was accompanied by public complaint signed by himself and 5 other consumers. In the Adalath, it was recommended to shift the line owing to safety issues and interruptions.

An estimate amounting to Rs.6,33,609 /- was prepared for shifting of the said line. On 04/03/2020, Sri. Renjithkumar filed another petition before the Hon'ble Minister for Electricity, informing his poor financial condition and that the purpose of shifting is for construction of a house in his property. The Hon' Minister thereupon directed to examine the possibility of giving concession of SOC and Supervision Charges and to consider departmental execution of work and to give concession as per Adalath guidelines.

Accordingly, the Deputy Chief Engineer, Electrical Circle, Kottayam, as per letter read as 1st above, furnished the estimate amount after waiving the SOC, Supervision charges and GST thereon as Rs 5,60,194/-.

The matter was placed before the Full Time Directors for a decision as per note read as 5th above.

Having considered the matter in detail, the Full Time Directors in its meeting held on 26/08/2020,

- 1. Resolved to accord sanction to the Deputy Chief Engineer, Electrical Circle, Kottayam to waive the SOC and Supervision charges for the said work.
- 2. Also resolved to allow a further concession of 25% on the estimate cost.

Orders are issued accordingly.
