### ORDER

KSEBL as per order read as 1<sup>st</sup> above had approved the conditions for permitting fishing in reservoirs of KSEBL after considering safety and related aspects.

The Director, Fisheries has requested permission for fishing rights in Banasurasagar Reservoir of KSEBL. As per letter read as 2<sup>nd</sup> above permission was granted to the Fisheries Department for fish farming by the SC/ST Fisherman group/Societies residing near the reservoir, subject to the conditions stipulated in the above Board Order.

The meeting convened by the Hon'ble Minister for Electricity and Hon'ble Minister for Fisheries, on 13.05.202 discussed the prospects of implementing a project on Cage Fish Farming in the Banasurasagar Reservoir of KSEBL under Rebuild Kerala Initiative (RKI). It was decided to

issue permissive sanction from the Board to start cage fish farming in the Banasurasagar Reservoir without affecting the floating solar plant and activities of the Hydel Tourism.

The Chief Engineer (Civil-Dam Safety & DRIP) as per letter read as 4<sup>th</sup> above has reported that the Fisheries Department has already brought necessary fishing cages to the site and recommended to accord sanction to comply the decision taken in the meeting to issue permissive sanction from KSEBL to start cage fish farming in the Banasurasagar Reservoir without affecting the floating solar plant and activities of the Hydel Tourism.

The proposal was placed before the Full Time Directors as per note read as 5<sup>th</sup> paper above. Having considered the matter in detail, the Full Time Directors in its meeting held on, 26.08.2020, resolved to accord permissive sanction to start Cage fishing in the Banasurasagar Reservoir without affecting the Floating Solar Plant and the activities of the Hydel Tourism.

Further resolved that an agreement between KSEBL and Fisheries Department shall be executed with appropriate clause to safe guard Solar Plant, Dam Safety, Hydel Tourism activities, etc.

The Chief Engineer (Civil-Dam Safety & DRIP) shall take further necessary action in this regard.
