ORDER

As per B.O. read as 2nd above, the Standard Operating Procedure (SOP) for shifting of assets of the utility for facilitating roads works along with the guidelines for preparing estimates (shifting of the assets of the utility for facilitating road works) attached as Annexure I was approved for forwarding to the Government for approval. The details were taken up with the Government as per letter read as 3rd above for necessary approval.

In the meeting held on 14/08/2020 with the Additional Chief Secretary (Water Resources Department) to discuss the issues pertaining to the shifting of utilities, KSEB Ltd was requested to make an online system for shifting of utilities similar to the online system in PWD for according road cutting/Right of Way permission. Further, standard estimates for shifting of utilities for various types of installations are to be prepared for the smooth execution of the works.

The matter was placed before the Full Time Directors as per note read as 4th above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 26/08/2020 resolved to accord sanction for the following:

- 1. To entrust the IT Wing to develop an online platform for processing the cases of shifting of utilities.
- 2. To entrust the Committee formed for preparing Standard Operating Procedure with preparing standard estimates for shifting of utilities for various types of installations as required, by forming suitable Sub Committees for preparation of standard estimates under intimation to the Office of the Director (Distribution, IT & HRM).
