ABSTRACT

Cutting and removal of 19 nos. of trees in the land proposed for the construction of 110kV Substation, Mannuthy - Sanctioned - orders issued.

ORDER

The Chief Engineer, Transmission North as per letter read as 1st above has reported that 19 Nos. of trees standing in the land proposed for the construction of 110kV Substation, Mannuthy are to be cut and removed. The Assistant Forest Conservator, Social Forestry Division, Thrissur has done the valuation of the trees and the amount comes to Rs. 3,40,643/- .

The proposed trees to be cut are in the land owned by Kerala Veterinary and Animal Science University & Irrigation Department and both the departments have given consent to KSEBL for conducting auction and for remitting the amount offered in the auction to the accounts of the respective departments.

The Executive Engineer, Transmission Division, Thrissur had conducted the Tender cum auction for the cutting and disposing of the trees three times after giving wide publicity. In the first time no tender was received and no one participated in the auction. In the second time no one participated in the auction and only one tender was received and the quoted amount was only Rs. 85,000/-. In the third time no auction conducted and three tenders were received. The highest offer received is Rs.1,02,000/- which is only 29.94% of the assessed value.

The Chief Engineer Transmission North has requested sanction to confirm the auction at 29.94% of the assessed value in favour of Sri. Abdul Basheer K.A., Kallinkalparambil House P.O., Chelakkara, Thrissur at his offered rate of Rs.1,02,000/-.

The matter was placed before the Full Time Directors as per note read as 2nd above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 26.08.2020, resolved to accord sanction to confirm the Tender cum auction conducted for the disposal of trees in the land proposed for the construction of 110kV Substation Mannuthy at 29.94 % of the assessed value with eligible taxes and duties in favour of Sri. Abdul Basheer K.A., Kallinkalparambil House, P.O. Chelakkara, Thrissur, which amounts to Rs.1,02,000/- (Rupees One Lakh Two Thousand only) + GST + Forest Development charges + Income Tax on Timber.

Orders are issued accordingly.


