ORDER

The Construction works of Kakkayam Small Hydro Electric Project (2 X 1.5 MW) has been completed and subsequently the project has been commissioned and dedicated to the nation on 16.07.2018. During the period of construction, the Erection Sub Division, Kakkayam with sanctioned strength of one place of AEE (Ele) and two places of AE (Ele.) was functioning under the administrative control of the Project Manager, Chembukadavu-III & Marippuzha SHEP.

Consequently, KSEBL as per order read as 1st above *inter-alia* accorded sanction to shift the administrative control of the Erection Sub Division, Kakkayam from Project Manager, Chembukadavu-III &Marippuzha SHEP to the Generation Division, Kakkayam.

Meanwhile the Chief Engineer(CC) North as per order read as 2nd above has requested for retaining the administrative control of the Erection Sub Division, Kakkayam with the Project Manager, Chembukadavu-III &Marippuzha SHEP citing the administrative conveniences.

Subsequently the Chief Engineer as per letter read as 3rd above reported that, presently the works associated with Peruvannamuzhy & Chathankottunada SHEPs in Kozhikode District and PazhassiSagar SHEP in Kannur District are being attended by the Erection Sub Division. The Chathankottunada SHEP is scheduled for commissioning in December 2020 and the works are in progress. The civil works of Peruvannamuzhy and PazhassiSagar SHEPs are progressing and the E&M works are already tendered. Tenders also floated for Maripuzha, Olikkal and Poovaramthode SHEPs.

All the erection works of the above mentioned projects come under the Erection Sub Division and reported many advantages in retaining of the Administrative control of the Erection Sub Division, Kakkayam with the Project Manager, Chembukadavu-III & Marippuzha SHEPs. Smooth, efficient and quick decision making for expeditious execution of these projects, identification and execution of extra items of works which are crucial for SHEP works with easiness, elimination of unnecessary problems related to accounting of work bills between the two ARUs etc. were highlighted as advantages.

In these circumstances, the Chief Engineer (CC-North) has requested for retaining the administrative control of the Erection Sub Division, Kakkayam with the existing staff pattern under the Project Manager, Chembukadavu III & Maripuzha SHEPs.

Accordingly, the matter was placed before the meeting of the Full Time Directors as per note read as 4 above for approval. Having considered the matter in detail the Full Time Directors in the meeting held on 12.08.2020, resolved to accord sanction to retain the administrative control of the Erection Sub Division, Kakkayam with the existing staff pattern under the Project Manager of Chembukadavu III & Maripuzha SHEPs for administrative convenience.

Orders are issued accordingly.
