ORDER

As per Board order read as 1st above, the Full Time Directors in its meeting held on 25.06.2020, had resolved to ratify the action of the Deputy Chief Engineer (Commercial & Planning) with full powers of Chief Engineer in having submitted the remarks on the 44 numbers of 'observations and comments' of KSERC on the bidding documents for procurement of 200 MW Solar power on All India basis to KSERC within the time limit in anticipation of sanction.

The Hon'ble Commission had examined the remarks of KSEBL and informed as per letter dated 03.07.2020 their direction on the remarks for which deviation was sought by KSEBL. It was also directed to modify the bid documents (RfS and PPA) accordingly and submit the same for approval. Hence the bid documents (RfS and PPA) already submitted to KSERC for approval on 6th March 2020 for procurement of 200 MW Solar power on All India basis has been modified incorporating the remarks of KSERC on the 44 nos of observations.

The Deputy Chief Engineer (Commercial and Planning) with full powers of Chief Engineer as per the note read as 2nd above had sought approval to submit the modified bid documents viz. draft RfS and draft PPA before Hon'ble KSERC and if so to upload the bid documents (RfS and PPA) in the DEEP portal of MSTC and publish in the official website of KSEBL, on approval of the same from KSERC. Considering the urgency, the Chairman and Managing Director, KSEBL had approved the modified bid documents for submission to KSERC and also to seek ratification.

Accordingly the Deputy Chief Engineer (Commercial & Planning) with full powers of Chief Engineer had submitted the modified bidding documents to KSERC on 30.07.2020 and requested for ratification of his action vide note read as 3rd above.

Having considered the matter in detail, the Full Time Directors in its meeting held on 12.08.2020, resolved to ratify the action of Deputy Chief Engineer (Commercial & Planning) with full powers of Chief Engineer in having submitted the bid documents viz. draft RfS and draft PPA before Hon'ble KSERC on 30.07.2020.

Also resolved to upload the bid documents (RfS and PPA) in the DEEP portal of MSTC and publish in the official website of KSEBL, on approval of the same from KSERC.
