ORDER

8 kms ACSR Moose Conductor and 50 kms of ACSR Dog Conductor are required as per Purchase Plan 2020-21. The previous Purchase Orders for 100 kms of ACSR Moose Conductor was placed as per PO read as 2nd above for supplying 100 kms for the construction of Pothencode - Kattakada line and 104 kms of ACSR Dog conductor for normal targetted work

as per P.O. read as 5th above with M/s Traco Cable Company Limited, Kochi on variable price basis as per Purchase Plan for the year 2017-18. The firm has completed the supply. Subsequently an additional Purchase Order read as 3rd above was issued for ACSR Moose conductor to meet the requirement of the year 2016-17 and two more additional Purchase Orders for ACSR Moose 5 kms each were issued to meet the requirement of Purchase Plan 2017-18 and for carrying out the work under PSDF Scheme as per PO read as 4th above. The Additional orders for 60kms ACSR Dog Conductor were also placed at the same rate, terms and conditions of the original purchase order as per PO read as 6th & 7th above for DDUGJY & IPDS scheme.

As per Clause 10 of the original Purchase Order, "the supplier shall be prepared to supply an additional quantity upto 25% in excess of the ordered or tendered quantity will be placed if the supplier is willing to supply the additional quantity at the same rates, terms and conditions of the original order and also accepts the KSEB Ltd's refixation clause such as the price for this additional quantity shall be refixed if a fall in price occurs in the next tender/purchase order for the materials with the same specifications supplied and accepted by the KSEB Limited and opened during the delivery schedule fixed for this additional quantity." Here the additional order have already been placed with M/s Traco Cable Company Limited for the supply of ACSR Moose and Dog and completed the supply.

The firm has submitted their willingness as per letter read as 8th above to supply additional quantity as per requirement of KSEBL at the rate of the latest order for ACSR Moose and Dog.

The matter is placed before the Director (G-E &SCM) for decision for the procurement of 8 kms ACSR Moose Conductor by placing order with M/s.Traco Cable Company Limited as per Purchase Plan 2020-21 and for the procurement of 100 kms ACSR Dog as per the note read as 9th above or 50 kms of ACSR Dog as per Purchase Plan 2020-21, then the Director (G-E & SCM) authorized to place the matter before the Full Time Directors.

The Director (Generation-Electrical & SCM) in the note read as 10th above ordered that as per Purchase Plan 2020-21, 8 kms ACSR Moose and 50 kms of ACSR Dog Conductors is required and to place the note accordingly. Hence, the matter was placed before the Full Time Directors as per note read as 11th above.

Having examined the matter in detail, the Full Time Directors meeting held on 12/08/2020

Resolved to accord sanction to authorize the Chief Engineer (SCM) for placing orders for additional quantity to M/s Traco Cable Company Limited , Kochi to meet the requirement of 8 km ACSR Moose at a financial commitment of Rs.31,35,206.16 (Variable)(43% above the original ordered quantity) .

Further resolved to accord sanction to procure 50kms of ACSR Dog Conductor as per Purchase Plan 2020-21 at a financial commitment of Rs.35,31,740/- (variable) (105.76% above the original ordered quantity) and to authorize the Chief Engineer (SCM) for placing orders for additional quantity to M/s Traco Cable Company Limited , Kochi

Orders are issued accordingly.
