# ORDER

The Assistant Secretary, Thrissur Corporation Electricity Department (TCED) had submitted a letter read as 1<sup>st</sup> above to the Chairman and Managing Director, KSEBL, with a list of materials and had requested to arrange the same which are required for distribution of Electricity to TCED by KSEBL.

There are many decentralized items and a very few centralized items included in the list and the total financial outlay for centralized items comes to Rs.93,24,063.48.

The request was made by the Thrissur Corporation Electricity Department (TCED) based on the observation of Kerala State Electricity Regulatory Commission in OP No.8/2018 dated 12/02/2019, regarding the approval of their cost data for distribution works for the Financial Year 2018-19.

The matter was discussed in the Full Time Directors meeting with remarks from the Deputy Chief Engineer (SCM) in charge, the Deputy Chief Engineer (Commercial & Planning) with full powers of Chief Engineer and Financial Adviser, KSEBL.

It was observed that many practical and procedural difficulties will be encountered if the request of TCED is considered.

Having examined the matter in detail the Full Time Directors in the meeting held on 12/08/2020 resolved to intimate Thrissur Corporation Electricity Department the practical difficulty in considering the request favourably.
