The Executive Engineer, Civil Division, Vydyuthi Bhavanam, Thiruvananthapuram has initiated action to issue the work order and execution of contract agreement with the firm and M/s Blue Star Ltd as per their letter No.51/AMC/RC/200702 dated 02.07.2020 has informed that the terms of the payment for comprehensive AMC is yearly in advance, against the production of Bank Guarantee for an equivalent amount from any nationalized/ scheduled banks having validity till the last date of the respective year of contract.

It is pointed out that the total AMC amount of 8 Nos. of Air Conditioners for the  $1^{st}$ ,  $2^{nd}$  and  $3^{rd}$  year are ₹50,622/-, ₹54,671/- and ₹59,046/- respectively including applicable GST and that the same firm has been carrying out the AMC work of Air Conditioners installed at SCADA control in the Vydyuthi Bhvananam, Thiruvananthapuram and KSEBL has accorded sanction for payment of full AMC amount per year in advance to the firm against Bank Guarantee.
