ORDER

The shortage of cleaners,helpers etc in Vydyuthi Bhavanam,Thiruvananthapuram is being managed by engaging persons from Kudumbashree Mission on daily wage basis based on agreements executed between the Executive Engineer,Civil Division,Thiruvananthapuram and the Kudumbasree Mission in each year. The wages of each category are being paid based on the Government Orders issued in this regard and adopted in KSEBL from time to time. KSEBL as per order read as 1st above has ordered to furnish a report on the need based deployment of contract staff in Vydyuthi Bhavanam engaged through Kudumbashree Mission .

Accordingly the Chief Engineer(Civil Construction – South) as per note read as 2nd above has furnished a detailed report on the matter to KSEBL. In the report it is pointed out that the required man power supply for the current year has been arranged as per two separate contract agreements with the Keralashree Social Service Society, which is functioning under Kudumbashree Mission, as authorised by the District Mission Co-ordinator. It has also been reported the necessity and the number of manpower engaged from Kudumbashree Mission for various jobs in Vydyuthi Bhavanam, Thiruvananthapuram including the Creche functioning in the building.

In order to ensure unhindered functioning of offices, the Chief Engineer(Civil Construction - South) has requested sanction for engaging persons from Kudumbashree Mission for various jobs in Vydyuthi Bhavanam, Thiruvananthapuram. The details regarding the sanctioned strength and working strength of Office Attendants in various offices in Vydyuthi Bhavanam is also presented before the KSEBL

The matter was placed before the Full Time Directors as per note read as 3rd above. Having considered the matter in detail the Full Time Directors of KSEBL, in the meeting held on 12.08.2020, Resolved to accord sanction to the Executive Engineer, Civil Division, Thiruvananthapuram to continue the contract with Keralashree Social Service Society, which

is functioning under Kudumbashree Mission, for the supply of Helpers and Cleaners on need based requirement in Vydyuthi Bhavanam, Thiruvananthapuram.

Further resolved to limit the total number of Office Attendants in Vydyuthi Bhavanam to the sanctioned strength of 78.

Further resolved that the Chief Engineer(HRM) shall take action to re-visit the sanctioned strength in various sections particularly in the office of the Chief Engineer(HRM), Chief Internal Auditor,Secretary(Administration), Financial Adviser and to implement a rational redeployment within 3 months. The deficiency in the sanctioned strength can be filled up through Kudumbashree.

Orders are issued accordingly.
