Abstract

Request for allotting vehicle (jeep) for the use of the Overseer Office, Mankulam under Electrical Circle, Thodupuzha – Sanctioned – Orders issued

ORDER

The Chief Engineer (Distribution Central), Ernakulam as per letter read as 1st above reported that the Deputy Chief Engineer, Electrical Circle, Thodupuzha had requested for allotting a vehicle (jeep) for the use of the Overseer Office at Mankulam based on the following details. Mankulam area comes under the jurisdiction of Electrical Section, Chithirapuram and is located at a distance of about 65 km from the Headquarters. The places including Mankulam, Thalukandam, Virippara, Kurathikkudi, Kattukudi, Kodakallu Kudi etc. comes under this region which is having an approximate area of 125 sqkm and has a consumer strength of more than 5,000 numbers. The supply to this region is from Pallivasal Power House through 11 kV Kallar over head line. Since the lines are through forest and cardamom fields, supply interruption is common during heavy rains and winds. An Overseer Office was temporarily started at Mankulam for limiting the supply interruptions to an extent. But timely rectification of complaints during natural calamity are not possible due to the lack of a vehicle. Also local vehicles are not available to reach tribal colonies of Kurathikkudi.

Due to the huge amount of complaints and maintenance works under Electrical Section, Chithirapuram (jurisdictional area of 510 sqkm), it is not possible to spare the allotted vehicle (jeep) for the use of Mankulam area. Hence the timely rectification of complaints in Mankulam area are not possible, inviting frequent protests from the authorities of Mankulam Grama Panchayat. In addition to this, the works of Upper Kallar SHEP is nearing completion and the construction of new 11 kV feeder is going on for power evacuation. So it is urgent to complete the works in the Mankulam region. The Mankulam region is having an area of 125 sqkm, consumer strength above 5,000 numbers, 47 transformers, 78 km of HT line and 265 km of LT line. The Tribal colonies of Kurathikkudi, Nooramkara, Plamalakkudi, Kattukudi, 6th Mile Kudi, Thalukandam, Anakkulam etc comes in this region and the approximate bimonthly revenue comes to ₹25-30 lakh.

In the circumstances, the Chief Engineer (Distribution Central), Ernakulam requested sanction for allotting a contract vehicle (four wheel drive jeep) with a monthly usage limit of 1,500 km for the use of Overseer Office, Mankulam.

The matter was placed before the Full Time Directors as per note read as 2nd above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 12/08/2020 resolved to accord sanction for hiring a contract vehicle (four wheel drive jeep) with a monthly limit of 1,500 km for the use of Overseer Office, Mankulam under Electrical Circle, Thodupuzha.

Orders are issued accordingly.
