## **ORDER**

The Government Medical College, SAT Hospital, Thiruvananthapuram is an HT consumer of Electrical Section, Ulloor under Electrical Circle (Urban), Thiruvananthapuram. The ToD meter installed at the premises of the consumer was faulty from 15.02.2020 and the same was intimated to the consumer on 23.03.2020 as per letter read as 1<sup>st</sup> above. Hence, average consumption for 195312 units (Kwh) is taken for billing for the consumption month of 01/2020 onwards. As per Part.II.B 4(d) General Conditions of HT/EHT consumer the period of 60 days was covered on 21.05.2020.

As per request read as 2<sup>nd</sup> above, the Principal, Government Medical College requested to extent 4 months time to replace the meter since the supervision work being done under the PWD Electric Wing and due to the lock down declared by the Government, they could not replace the meter in time. It is also stated that they are now giving more attention and importance to prevent the COVID-19.

There is no current charge arrear pending against the consumer.

The Director (Finance) in the note read 3<sup>rd</sup> above directed to put up the matter before the Full Time Directors. Accordingly the subject matter was placed before the Full Time Directors as per note read as (4) above. Having examined the matter in detail, the Full Time Directors in its meeting held on 14.07.2020, resolved to accord sanction to consider the request of the consumer [Government Medical College – SAT Hospital (LCN 19/6473)] to extend 4 months time i.e., upto 30.09.2020, to replace the faulty meter. Considering that the consumer is Government Institution.

Orders are issued accordingly.
