ABSTRACT

Cutting and removal of 26 nos. of trees at 110kV Substation, Thalassery - Sanctioned - orders issued.

ORDER

The Chief Engineer, Transmission North as per letter read as 1st above has reported that 26 Nos. of trees standing in the 110kV Substation compound Thalassery are to be cut and removed for the construction of 220kV GIS Thalassery. The Assistant Forest Conservator, Social Forestry Division, Kannur has done the valuation of the trees and the amount comes to Rs. 40,612/-.

The quotation cum auction was conducted twice by the Assistant Executive Engineer, Transmission Sub Division, Thalassery. In the first time no quotations were received and 2 bidders participated in the auction. The highest offer received was Rs.10,000/- which is only 25% of assessed value. In the second time no quotations were received and 2 bidders participated in the auction. The highest offer received was Rs.18,000/- which is only 44.32% of assessed value.

In view of the urgency of TransGrid work and by considering the fact that the work was auctioned twice, the Chief Engineer, Transmission North has requested sanction to confirm the auction at 44.32 % of the assessed value in favour of Sri. P.V. Padmanabhan, Padmaragham, P.O. Pinarayi, Kannur at his offered rate of Rs.18,000/-.

The matter was placed before the Full Time Directors as per note read as 2nd above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 22.07.2020, resolved to accord sanction to confirm the Quotation cum auction conducted for the disposal of trees in the 110kV Substation compound at Thalassery at 44.32 % of the assessed value with eligible taxes and duties in favour of Sri. P.V. Padmanabhan, Padmaragham, P.O. Pinarayi, Kannur, which amounts to Rs.18,000/- (Rupees Eighteen Thousand only) + GST + Forest Development charges + Income Tax on Timber.

Orders are issued accordingly.
